Top Teens of America Story

Sponsored by Top Ladies of Distinction, Inc.



The eight Founders of Top Ladies of Distinction, Inc. had as the first objective for TLOD to help alleviate the moral and social problem engulfing the youth in 1964 via a youth organization.

In 1968 while meeting in Fort Worth, Texas, the membership of Top Ladies of Distinction, Inc. decided that the group should have an official name. Lady Cordelia Mackey, President of the Texarkana Twin City Chapter, suggested the name of Top Teens of America. The name was adopted.

In 1969, there was a need to form a Top Teens of America group in each chapter of Top Ladies of Distinction. A committee was appointed and resultantly, the first National Top Teens of America convention was organized.

The Houston Chapter of Top Ladies and Top Teens hosted a meeting to organize the National Top Teens. Teen representatives from all Top Teens of America chapters were in attendance, under the guidance of the National Director of Top Teens of America, Lady Willie Lee Glass, the first National meeting of Top Teens of America was held in Houston, Texas in 1969. Over three hundred Top Teens were in attendance. Top Teen Harnell Price of the Rose City Chapter, Tyler, Texas was elected as the first TTA National President. At this convention, the purposes of TTA were defined.

The Purpose of organization shall be to:

- a) encourage high academic scholarship;
- b) develop social graces, leadership and fellowship abilities;
- c) develop pride in self; home and community;
- d) encourage participation in workshops which address current fronds;
- e) work collaboratively with other organizations to reach mutual goals;
- f) develop deep concerns for senior citizens, status of women, community beautification and community partnerships;
- g) encourage appreciation for ethic and cultural heritage.

The TTA projects have expanded over the years to include:

- Participation in the NAACP
- Participation in UNCF
- Participation in NCNW
- Participation in the AOIP
- Sickle Cell Disease Awareness
- March of Dimes
- Mentoring Program/TLC

In October 1983, the TTA program was further expanded to include a collaborative project with the National Foundation March of Dimes. The Program was known as **Teens Outreach Program and Service. TOPS**, a peer education program, designed to inform youth about drugs and alcohol abuse, sexually transmitted diseases and birth defects through workshops, seminar, and conferences. Parents were encouraged to participate. TOPS through education also enabled youth to make critical decisions regarding their lives.

In January 1996, the March of Dimes Birth Defects Foundation and Top Ladies of Distinction, Inc. extended its youth peer education through a newly developed program known as **Healthy Choices: Your Future and You**. A TTA/MOD guide was written and circulated to all TLOD Chapters to assist them with implementation of this health conference program. The major purpose of this program focuses on leadership development, critical decision making, adolescent health issues and the support of Walk America.

The **“Me and My Mentor”** Program was initiated in 1995. Every Top Lady was encouraged to personally touch the lives of Top Teens through one-on-one nurturing and the development of relationships that foster mutual trust and respect.

Top Teens of America members shared mentor and mentee relationships through “Me and My Mentor” publication in 1997 and 1999.

Since 1968 thousands of youth in secondary schools, nationally and internationally have benefited from membership in Top Teens of America.

Top Teens of America

Syn-Lod Code of Ethics

1. All Top Teens are expected to be present at all meetings and activities. If a Teen is not going to be present, the Advisor must be notified at once as to where the Teen will be and the reason for not being present.
2. All curfews must be followed. All Top Teens must be settled in their room by 12:00 PM **(MANDATORY)**. There will be absolutely no visitation in rooms after this hour. The National Top Teens Director will determine any extensions of this hour.
3. Top Teens are not to leave the convention site under any circumstances without the permission of and direction from their Top Teens Advisor. Any Teen doing so, without permission, will be disciplined. All TLOD members (mother, aunt and/or grandmother) must respect directives of TTA Advisors when TTA members leave home under the auspices of TLOD members.
4. There shall be no co-ed visitations in the hotel sleeping rooms. No Exceptions. Any co-ed visitation will be considered a breach of the Code of Ethics and will be handled accordingly.
5. Alcoholic beverages, marijuana, any illegal stimulants or depressants are not permitted at any conference, convention, function or activity of Top Teens of America. Any Teen found with any of these substances will be disciplined. Parents and the proper authorities shall be notified of any Teen's involvement in any illegal activities and shall be sent home at the parent's expense.
6. Top Teens shall conduct themselves in a manner that will be a credit to the organization: good manners, proper attire and avoid unnecessary boisterousness. Top Teens should never be guilty of being loud. Therefore, always keep in mind that Top Teens should act like young ladies and young men.
7. Dress for the occasion: Dressy/business attire for all meetings; dressier attire as required for the occasion; hemlines should be no more than three (3) inches above the knees at any time. There shall be no bare ankles, short shorts or above the knee pants for special activities where pants can be worn.
8. Do not run in the halls or gather in unassigned areas. Top Teens are guests of the convention site; therefore, we must respect the hotel's property.
9. Top Teens shall abide by the convention site rules and regulations.
10. A National Top Teens Review Board shall be appointed to review cases of Teens breaking the Code of Ethics.
 - a. The Review Board shall be composed of seven (7) Top Teens of America members (National TTA President and one Teen from each Area), three (3) TTA Advisors from the National Advisory Council and the National TTA Director. The National TTA President shall preside. Should the original grievance be against the National TTA President, the national officer on the Review Board shall be the National TTA First Vice President.

- b. The decision of the Board is final upon consultation with the National President of Top Ladies of Distinction, Inc.
 - c. Penalties for infractions shall be as follows:
 - (1.) Chapter becomes ineligible to compete for awards.
 - (2.) Chapter shall forfeit any awards received.
 - (3.) Fines shall be imposed upon the Teen(s) and their Chapter(s), not to exceed \$25.00 per infraction; and/or
 - (4.) Community service time (documented by the Chapter TTA Advisor).
 - (5.) Monies collected from fines shall be designed for scholarship(s) to be awarded from the National TLOD body.
 - d. Please refer to Article III Membership, section 5: "A member may be fined and/or suspended from Top Teens of America for breach of the Code of Ethics by the Review Board. Additionally, Article III Membership, section 6 states, "Membership in Top Teens of America may be terminated at the request of the membership, after being brought before the Review Board for violation of the Code of Ethics."
11. Safety rules must be followed at all times. Swimming is prohibited.
12. Inappropriate physical contact (i.e. groping, touching, fondling, bumping and grinding), and any other conduct and behavior that is not considered appropriate in front of your mother is prohibited. Likewise, there is zero-tolerance for fighting. Violators will be subject to established consequences.
13. Top Teens must follow all local, state and federal laws without question.
14. Profane, swearing and any abusive language is prohibited.
15. Personal music is permitted for the listener only. It is not for others to hear. Earphones must accompany MP3 Players.
16. Photographs cannot be publicly displayed, video-taped, electronically downloaded or otherwise captured without the written consent of the legal guardian of the Top Teen. Teens are prohibited from taking inappropriate photos of other Top Teens with cell phones and downloading them on the computer.

My signature indicates that I have read, understood and will comply with the established Code of Ethics. Failure to do so will result in National, Area & Chapter imposed sanctions, parents being contacted/notified and/or Teen being sent home from conference site or planned activity at their parents' expense.

CONFERENCE RULES

The following rules are presented to the voting delegates of the 40th Syn-Lod for Adoption. The Order of Business shall be the same as printed in this workbook if adopted or amended.

General Rules

1. The first order of business will be the adoption of these rules and the agenda for the sessions of the conference.
2. Teens attending the 40th Syn-Lod shall be recognized as
 - Voting Delegates
 - (Chapter Delegates, National Officers, Program Thrust Chairs and Standing Committee Chairs)
 - Alternate Delegates
 - Non-Voting Delegates
3. All Teens attending the conference shall be required to wear their official badge to all conference activities.
4. A majority of the Voting Delegates shall constitute a quorum.
5. All voting delegates shall occupy their assigned seats.
6. No Delegates shall vote unless he/she is in his/her assigned seat.
7. When a Voting Delegate vacates his/her seat, the Alternate Delegate shall replace him/her.
8. Top Teens, who arrive following the signal to close the doors at each business session, shall pay a fine of \$1.00 to gain entry to the session.
9. Top Teens, who are sleeping, texting, listening to music, or playing games during each business session, or other forum, shall pay a fine of \$1.00.
10. All monies collected shall be given to the National TTA Development Fund. Teens and Ladies shall be exempt from this rule if physically challenged

Motions

1. All motions made before the body shall be by Voting Delegates only.
2. A voting Delegate must second all motions
3. No motion shall be discussed until it is seconded.

4. Debate on all motions shall be limited to two (2) minutes.
5. No Delegate can speak more than twice on the same subject unless permission is given by the chair.

Discussion

1. No delegates shall speak unless recognized by the Presiding Officer.
2. Discussion on all questions shall be presided over in a fair and impartial manner.
3. All Delegates speaking to an issue must:
 - a) Move to the microphone.
 - b) Identify themselves by name and chapter before speaking to the subject.

Voting

Voting Cards shall be used to denote the vote.

Parliamentarian

The Parliamentarian shall, keeping with Robert Rules of Order, Newly Revised Edition, advise the President upon request.

Sergeant-at-Arms

The Sergeant-at-Arms shall identify and label Delegate seats, admit Delegates, ensure order, supervise the floor and issue material.

The Sergeant-At-Arms, timekeepers, and assistants are appointed to facilitate the order of the meeting.

They may restrict the entrance of late arrivals while reports are being presented.

Time-Keepers

Two (2) -Keepers shall monitor time.

Tellers

Two (2) Tellers shall be appointed to count votes when necessary.

Announcements

All announcements shall be made at the end of the business session, except in emergencies.

Electronic Devices

Top Teens and Top Ladies carrying electronic communication device shall set devices to silent/vibrate or in the off position during business sessions, workshops and/or forums.

No texting is allowed during business sessions, workshops and/or forums.

TOP TEENS, TEXTING DURING BUSINESS MEETINGS/ACTIVITY SESSION, SHALL PAY A FINE OF \$1.00. PHONE WILL BE HELD UNTIL END OF BUSINESS SESSION/ACTIVITY, IF VIOLATOR PERSISTS IN TEXTING.

PLENARY PROCEDURES

1. A member rises and addresses the presiding officer.
2. The presiding officer recognizes the member.
3. The member states the motion and submits a written copy to the recording secretary.
4. Another member seconds the motion.
5. The presiding officer states the motion to the body.
6. Members may discuss the motion, only if debatable.
7. Presiding officer calls for the vote.
8. Presiding officer announces the results.

NOMINATION GUIDELINES

1. All floor nominations made before the body shall be by Voting Delegates only.
 - a) All candidates nominated from floor must complete official nominating form with all required signatures.
 - b) **No person may sign another.**
2. Only two Nominations for any position may be from same chapter.
 - a) Campaign speeches will be limited to two (2) minutes and will be presented during the Plenary Session.

CANDIDACY GUIDELINES

1. Credentials will be verified by the Credentials Committee under the direction of the National TLOD Financial Secretary.
2. Teen's local chapter must be in good standing.
3. Teen must be an active member in a local TTA Chapter for at least one (1) year.
4. Teen cannot be a senior in high school.
5. Teen must have attended an Area Conference.
6. Teen shall serve for a term of two (2) years.
7. Teen must be financial on all level of organization.

CAMPAIGN MATERIALS AND CAMPAIGNING

1. Space will be provided to meet the candidates
2. Signs will depend on space available and hotel rules and regulations.
3. No campaigning at the balloting boxes
4. No campaigning during the actual Plenary Sessions.
5. All campaign materials must be in good taste.

ELECTION PROCEDURE GUIDELINES

1. Only official Chapter delegates, National officers, Program Thrust Chairs and standing Committee Chairs will be allowed to vote.
2. Delegates will sign in by Areas.
3. Delegates will receive a blue and white verification card once they have signed in.
4. Delegates will present their verification card to the person posted at the entry to the voting machine.
5. The voting process will be complete by using voting machines.

BUS TRAVEL GUIDELINES

1. All Teens must be seated at all times during the bus ride. The noise level must be kept to a minimum.
2. Teens must be accompanied by their TTA Advisor/ Assistant TTA Advisors or adult designee.
3. Any misconduct going to, while in attendance or returning from the offsite activity, will be dealt with in accordance to our Code of Ethics.

PROTOCOL

1. Protocol shall be properly established at the opening session of Syn-Lod.
2. All Teens and Ladies MUST stand when *National TTA President or National TLOD President is introduced or enter the room.*
3. Members presenting reports to TTA - National convention shall address the *National TTA President, Top Ladies and all Teens assembled.*
4. This is done only ONCE during session. All others greet the body...
5. All reports must be typewritten with copies submitted to the National TTA Recording Secretary immediately following presentation.
6. All Teens making presentations to the Entire body shall address the National Top Teens President, National President, Founder and all Ladies, Lords, Teens and Guest assembled. This is done only ONCE during session or event.
7. No applause after the singing of National Negro hymn or after meditation/prayer or grace.

Our major purpose, as we strengthen the chain of friendship throughout the world, is **SERVICE**. We ask for guidance of as we give of ourselves in fulfilling our purposes and responsibilities.

OFFICERS: (In Unison)

As officers of Top Teens of America, it is our duty and responsibility to provide the best leadership in the execution of our purposes.

MEMBERS: (In Unison)

TOPS IN SERVICE must be our watch word:

T is for Tops in Service:

O is for Outreach in working cooperatively with other organizations to reach common goals;

P is for Pride in self, home, and community:

S is for **Service**, our major purpose:

I is for Involvement to keep abreast of current advancements:

N is to seek New goals as we prepare to be leaders of tomorrow:

S is for Senior Citizens and the deep concern we show toward them:

E is to Encourage scholarship, participation, and appreciation of Ethnic History and Cultural Heritage:

R is for Radiate as we branch out into all directions:

V is for our combined Vision that encompasses the scope of all mankind:

I is to Instill in each of us the ideals and purposes of our organization:

C is for Commitment in developing social and personal skills necessary for entering and performing in the competitive society; and

E is for Encouragement as we strive to carry out our objectives as set forth by Top Ladies of Distinction, Incorporated.

Top Teens of America 40th Syn-Lod Conference Credentials and Delegates Rules

The rules presented below govern the delegate credential and voting strength process at the 40th Syn-Lod Conference.

Delegates and Voting Privileges

Voting at the Syn-Lod Conference is based on representation. Each chapter has is allocated delegates.

Delegates are apportioned by chapter as follows per the Standard Operating Procedure Manual, page 1.

Additional voting privileges are given to National TTA Officers (elected & appointed),

Voting strength is determined based on the number of active Teens in each chapter as of March 31, 2017.

Prior to the conference, the National Financial Secretary has provided the total strength per chapter based on membership and any additional votes for officers, etc. The Chapter Presidents and TTA Advisors were requested to confirm the delegate identification entered in the Registration system.

The National Financial Secretary confirms the credentials of the delegates and alternates to ensure they were eligible to vote (i.e. active as of March 31, 2017)

Officer, Delegate and Alternate ribbons identify members that are eligible to vote at the conference.

DELEGATE SIGN IN WILL BE 15 MINUTES BEFORE EACH PLENARY SESSION

Conference Plenary Session Voting

The National Financial Secretary is responsible for providing the voting strength for each plenary session.

Voting members (delegates and officers) for National will have designated seating.

Voting Delegates are required to certify prior to each plenary session in order to be seated (i.e. vote) in a given session. This includes chapter delegates and any other delegates with voting privileges. Delegates can only be replaced by certified alternates. If an alternate is being replaced, the financial secretary must confirm the eligibility of the new alternate.

Delegate certification will be done 30 minutes prior to each plenary session. Each delegate must sign-in to be credentialed and receive a voting card for the session. Once the credentials sheets are pulled, the voting strength for the session will be closed and no additional voting cards will be issued.

Voting strength will be announced at the beginning of each plenary session. Each delegate must have certified prior to the start of the session in order to be included in the chapter voting strength.

Late attendees will have to request to be seated from the presiding officer. The delegate will need to seek privileges of the floor, upon recognition by the presiding officer she shall state his/ her name, chapter indicating he/she is a delegate requesting to be seated. Upon recognition from the presiding officer, the voting strength will be amended by the Financial Secretary.

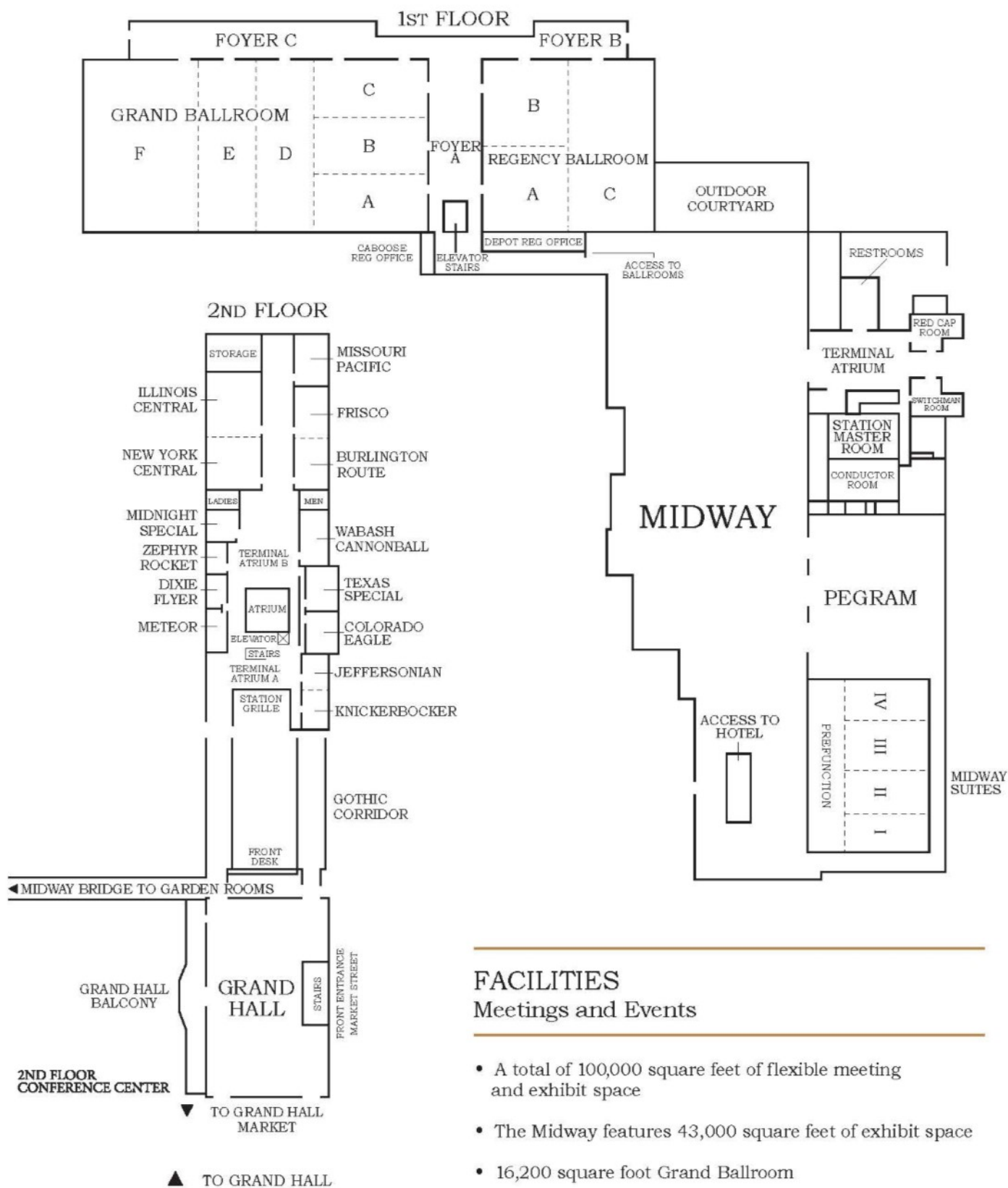
